INFORMATION SHEET
A RESORT FOR ISOLATION AND QUARANTINE – COVID-19

The Government of Maldives (“GOM”) represented by the Ministry of Tourism (“MOT”) invites eligible resorts to submit their Proposal for the project specified below;

Project – to operate a resort as an Isolation and Quarantine facilities to accommodate the positive and direct contact cases of Covid-19 from tourism industry.

Prerequisites

1. Minimum 50 rooms should be available for Isolation and Quarantine purposes.
2. The resort must be located in below mentioned atolls;
 - Male’ Atoll (K)
 - North Ari Atoll (AA)
 - South Ari Atoll (Adh)
 - Vaavu Atoll (V)
 - Lhaviyani (Lh)
 - Baa Atoll (B)
3. The resorts must be available for at least 03 month for the above-mentioned purposes.
4. Below mentioned services should be available for all the people isolated/quarantined in the resort;
 - Accommodation
 - 3 meals per day (International menu)
 - 3 bottles (1.5 litres) of mineral water per person
 - Tea/ Coffee arrangements
 - Internet Services (WiFi) – In room
 - TV Services with at least 10 international channels
 - Laundry Services
 - Housekeeping arrangements (Basic room amenities)
5. Security should be provided.
6. Rooms should be separately allocated for Isolation and Quarantine.
 - The resort can provide the services to the guests staying in the Isolation rooms as per HPA guideline.
 - The resort cannot provide normal services to the guests staying in the Quarantine rooms, and the guests should not be allowed to go out of the rooms.
7. Mandatory PCR testing arrangements and transportation of sample to a testing laboratory including payments should be ensured by the resort.
8. Adequate stock of PPE and UTM kits required for testing should be made available.





9. Accommodation and Food for the government health care professionals including space for clinic setup.
10. If needed, transportation arrangement for emergency transport of government health care professionals and medication.
11. Transport arrangement for the movements of tourists (positive or direct contact) if requested by the tourist facility.
12. All services rendered by the resort should comply with all regulations & guidelines published by relevant authorities.

Price

1. The party who fits the criteria and propose the lower price will get the maximum marks.
2. The maximum price that can be proposed is USD150 (One Hundred and fifty Dollars) with all taxes per room per day for a single person. Any Additional guest to the room can be charged as below;
 - USD60 (Sixty Dollars) including all taxes for an adult.
 - USD30 (Thirty Dollars) including all taxes for a Child.
3. It is the responsibility of the resort to collect the payment from the guests.
4. All the services stipulated in point (4) of the prerequisites should be included in the aforementioned price.

Additional Information

The Government will do the needful in relation to the monitoring of the guests isolated or quarantined in the resort.

- Clinical services/equipment will be provided by government.
- Healthcare professional to be provided.
- Land rent of the resort will be waived off for the period of utilization as an Isolation/Quarantine facility.

Composition of Proposal

1. Letter of Application- indicating Name, title address and telephone number, email of the Principal who will serve as the Contact for this project and make decisions for the firm on contractual matters.
2. Company Profile - details of the firm, company or partnership profile, expertise, resource capacity and brief background of senior management personnel.





3. Company Registration Copy.
4. GST Registration Certificate Copy.
5. Services – Services the resort can provide.
6. Price including taxes - Proposed price with details.

Language of Proposal

The proposal must be written in English.

Submission of Proposal:

All Proposals shall be submitted in enclosed envelope marked according to the Project as follows;
